For your convenience items have been grouped into rooms typically found in a house.

Insurance - Goods in Transit / All Risk insurance:

As with any other insurance, there is an excess on this policy of R2500 or 5% of the claim which ever is the greater. This excess is payable by the customer.

No cover exists in respect of the following cargo unless agreed with insurers in writing prior to cover commencing:

Antiques or antiquities of any description, artworks, ammunition, explosives, weapons of any description, fireworks, bank and treasury notes, bullion, cash, travellers cheques, camera's, cellular phones and accessories, iPads, iPods, iPhones, smart phones, android phones or communication devices, sunglasses, spectacles, laptops, mini computers, flat screen TV's, pre-paid phone cards, computers and memory systems, cobalt, copper in any form, copper cable, non-ferrous metals or stones, gold or silver articles, jewellery, watches, furs, models, moulds, patterns, plans, deeds, designs, documents of any description, securities, specie, stamps, tickets, cigarettes and tobacco products other than raw tobacco, specialized liquor collectables, hobby and valued collections. The above list whilst listed by the insurance company as being exclusions for cover. We have negotiated with the insurers on the fact that some people may want us to move antiques, artworks, computers, models and boxes containing some of the items listed. To that end we require you as the customer, to list those items with their current replacement values so that we can get the broker to deal with that aspect of the insurance. For the above exclusions, we recommend you insure it with your own insurance company.

Further Note: This insurance covers theft as a result of hijacking and armed robbery only.

We have 3 different types of insurance, please see breakdown below.

The excess for All Risk, In-Transit and Storage Insurance is set at R2 000.00 (Excl. VAT)

The insurance cover is not effective until the premium is paid in full

If boxes are packed by you and insurance for All Risk requested, max claim is R250.00 per box if lost or damaged

If boxes are packed by us and insurance for All Risk requested, max claim is R500.00 per box if lost or damaged

In-Transit cover does not entertain claims for lost or damaged boxes or any breakages or damages on furniture
